13) Upon inspection many bags of bulk foods stored directly on floor. (Recent delivery). Put food on shelves as soon as possible after delivery to prevent contamination.

13) Ice for drinks in bar area stored in bin with soda hoses ^{and cold plate} running thru ice. Ice for drinks can not come in contact with ice plate and hoses. Suggest using clean tub of ice for drinks.

36) CO2 canisters not chained to stable structure. Chains are present. Use chains for safety.

40) No apparent wiping cloth sanitizer bucket system. Either use once and launder or ^{store in sanitizer} between uses.
