- 13) Half bag of bulk food (flour). After opening bulk bag store the remainder in food grade container with lid.
- 13) Upon inspection food containers stored directly on floor in walk-in. Store all food 6 inches off floor at all times. Employee fixed
- 40) No sanitizer buckets present. Few wiping cloths out. Between uses store all wiping cloths used on food contact surfaces in 100 ppm Chlorine.
- 34) No test strips present. Chlorine strips must be present to check sanitizer section of 3 part sink and wiping cloth buckets. 100 ppm chlorine
