- 13) A few partial bags of bulk foods. After opening bulk food bags, if not all used at time, store the remainder in a labelled food grade container with lid.
- 13) Few displays in grocery area have food in box on bottom next to floor. All food must be stored 6 inches off floor at all times. Sodas + Beer excluded by code.
- 13) Few boxes, just delivered, containing food stored directly on floor. When food is delivered either put food on crates or cart to keep food from being contaminated. Keep off floor minimum of 6 inches.
