  - 4) Cutting surfaces to be sanitized between uses to avoid crosscontamination
  - 5) all food items to be kept @ least 6 inches off the floor in walk in
  - 6) Dry storage room floors are dirty - clean <sup>Remove clutter</sup>
  - 7) Sock wiping rags in sanitizer
  - 8) Reorganize walk in to avoid contamination
  - 9) Mop bucket outside - Do not dump outside.
