THIS DEPARTMENT RECEIVED A COMPLAINT WHICH ALLEGED THAT PIGEONS ARE CREATING A UNSANITARY DINING ENVIRONMENT UNDER COVERED OUTDOOR DINING AREA. PIGEON FECES, FEATHERS, NESTING TRASH ALLEGED THROUGHOUT AREA.

PIGEONS ARE STILL ROOSTING IN AREAS WHERE PLASTIC SPIKES HAVE BEEN INSTALLED. PIGEONS ROOSTING IN EYES AND ABOVE PILLARS. INSPECTION ON 5/19/14 REVEALED THAT PIGEONS & OTHER SMALL BIRDS WERE CREATING A HEALTH NUISANCE WHEN I SPOKE w/ MARY DELONG ON 9/4/14 AFTER KITCHEN FIRE SHE INFORMED US THAT PIGEON ISSUES WOULD BE RESOLVED. TO THIS POINT THE REPAIRS THAT WERE TO TAKE PLACE
