- (8) Time + date stickers missing from sliced tomatoes + cheese on prep line. When using Time as public health control, stickers must be used on all potentially hazardous items at all times. Corrected on site.
- (14) Pink mold-like residue on interior of ice machine. Clean + sanitize regularly.
- (40) Damp wiping cloths stored on counter tops. Store only in containers of sanitizer when not actively wiping counters.
