Proper utensil cleaning procedure is wash with hot, soapy water, rinse with clear water and sanitize with approved sanitizer. Utensils must be submerged in full basins of sink (okay to rinse under running water in 2nd basin if desired).

21 - No hot water at utensil sink faucet and hot water at hand sink is not maintained. Adjust/repair hot water heaters to maintain 120°F at utensil sink faucet and 100°F at hand sink faucet.

29 - Spray container ~~XXXXXXXXXX~~ Black Flag and HOT shot in cabinet by hand sink. Remove domestic insecticide from facility.
