Frosty started his career with Sutter County on December 28, 1999 as a Supervising Building Services Worker (Sup 36). In November 2001, the position was reclassified to a Building Services Supervisor (Sup 38). In February 2008, the position was reclassified to a Building Services Supervisor (Sup 39). In January 2015, the position was reclassified to Facilities Maintenance Superintendent (Mgt. 41). Frosty held this position until his retirement on January 5, 2018.

Frosty was involved in numerous major projects within the County such as remodels of various County buildings, management of Sheriff's Emergency Services Command Vehicle building, County's Energy Conservation Project with OpTerra Energy Solutions, re-roofing projects at seven County buildings, installation of video surveillance systems at three County buildings, installation of card access entry systems (Passpoint) at 11 County buildings, ADA improvements at Veterans Community Memorial Building parking lot, and a building remediation due to flooding at Probation Department.

Forrest (Frosty) Southard is highly regarded for his professionalism and personal demeanor by the employees of Sutter County within the General Services Department, by other departments within the County, and by the County's citizens.
